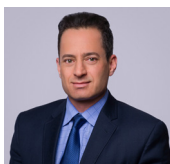

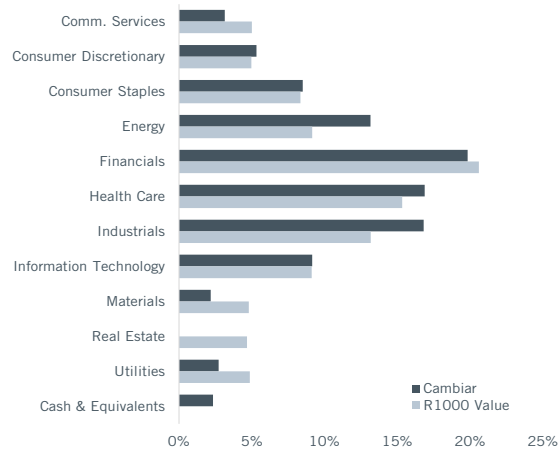

While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. The Cambiar Opportunity Fund was rated against 1,138 US-domiciled large value funds over a three year period, 1,084 over a five year period and 821 over a ten year period. With respect to these large value funds, CAMOX received a rating of 3 stars, 5 stars, and 4 stars, respectively. Past performance is no guarantee of future results.
