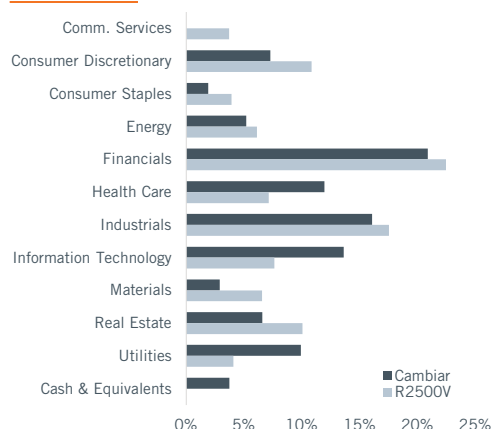

The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. The Cambiar SMID Fund was rated against 379 Mid-Cap Blend funds over a three year period, 349 funds a five year period, and 241 over a ten year period. With respect to these Mid-Cap Blend funds, CAMMX received a rating of 2 stars, 3 stars, and 3 stars, respectively. Past performance is no guarantee of future results.
