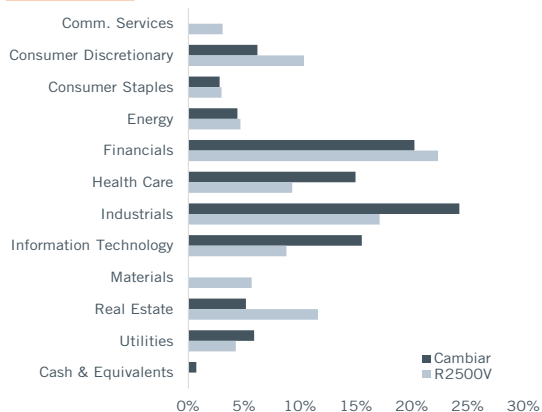

While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. The Cambiar SMID Fund was rated against 367 Mid-Cap Blend funds over a three year period, 335 funds a five year period, and 218 over a ten year period. With respect to these Mid-Cap Blend funds, CAMMX received a rating of 3 stars, 4 stars, and 4 stars, respectively. Past performance is no guarantee of future results.
