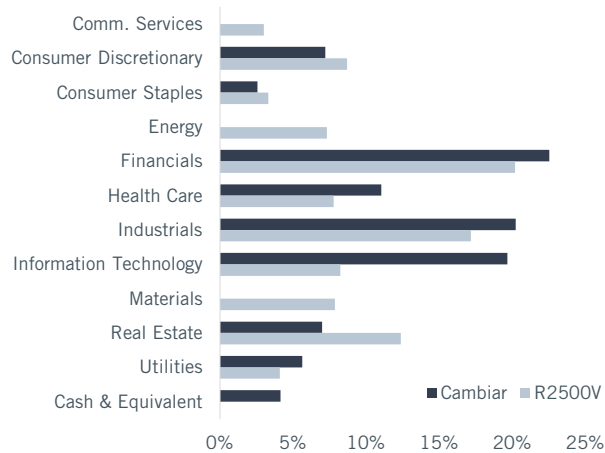

Prior to April 2020, the minimum asset level for the composite was \$100,000.
